

DECLARATION

Affidavit cum Declaration by Noor Mohammed, Promoter of the proposed project- "Kohinoor City".

I, Noor Mohammed S/o Deen Mohammed, Aged 78, R/O -Kohinoor Cinema Walon Ka House, Sindhigo Ka Mohalla, Sewanchi Gate Ke Ander, Jodhpur, Rajasthan-342001, do hereby solemnly declare, undertake and state as under:-



10. That Promoter shall not discriminate on the basis of caste, religion, region, language, sex or marital status against any allottee at the time of allotment of any apartment, plot or shop, as the case may be, on any grounds.


