- A. 1.4 It is agreed that the LLP shall not make any addition and alteration in the sanctioned plans, layout plans and specifications in respect of the Plot without the previous written consent of the Allottee(s) as per the provisions of the Act:

Provided that the LLP may make such minor additions or alterations as may be required by the Allottee(s), or such minor changes or alterations as per the provisions of the Act.

- 1.5 Subject to Term No. 8.3 the LLP agreed and acknowledges, the Allottee shall have the right to the Apartment/ Plot as mentioned below:
  - (i) The Allottee(s) shall have exclusive ownership of the Plot;

- 1.6 It is made clear by the LLP and the Allottee agrees that the Plot shall be treated as a single indivisible unit for all purposes. It is agreed that the Project is an independent, self-contained Project covering the said Land and is not a part of any other project or zone and shall not form a part of and/or linked/combined with any other project in its vicinity or otherwise accept for the purpose of integration of infrastructure for the benefit of the Allottee.
- 1.7 The LLP agrees to pay all outgoings/ dues before transferring the physical possession of the plot to the Allottee(s) which it has collected from the Allottee(s), for the payment of outgoings/dues (including land cost, ground rent, municipal or other local taxes, charges for water or electricity, maintenance charges, including mortgage loan and interest on mortgages or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the Project). If the LLP fails to pay all or any of the outgoings/ dues collected by it from the Allottee(s) or any liability, mortgage loan and interest thereon before transferring the plot to the Allottee(s), the LLP agrees to be liable, even after the transfer of the property, to pay such outgoings/ dues and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any legal proceedings which may be taken therefore by such authority or person.

#### 2. MODE OF PAYMENT:

Subject to the terms of the agreement and the LLP abiding by the construction milestones, the Allottee shall make all payments, on written demand by the LLP, within the stipulated time as mentioned in the payment plan at Term No. 1.3 above through account payee cheque/demand draft/ banker's cheque or online payment (as applicable) in favor of HAPPY REALSQUARE LLP payable at JAIPUR.

#### 3. COMPLIANCE OF LAWS RELATING TO REMITTANCES:

- 3.1 The Allottee, if residence outside India, shall be solely responsible for complying with the necessary formalities as laid down in Foreign Exchange Management Act,1999 ('FEMA'), Reserve Bank of India Act, 1934 ('RBI' Act) and the Rules and Regulation made there under or any statutory amendments or modifications made thereof and all others applicable laws including that of remittance of payment, acquisition/ sale/ transfer of immovable properties in India etc. and provide the LLP with such permission, approval which would enable the LLP to fulfill its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of FEMA or statutory enactments or amendments thereof and the Rules and Regulation of the Reserve Bank of India or any other applicable law. The Allottee understands and agrees that in the event of any failure on his/ her part 2 comply with the applicable guidelines issued by the Reserve Bank of India, he/ she may be liable for any action under FEMA or other laws as applicable, as amended from time to time.
- 3.2 The LLP accepts no responsibility in regard to matters specified in Term 3.1 above. The Allottee shall keep the LLP fully indemnified and harmless in this regards. Whenever there is any change in the residential status of the Allottee subsequent to the signing of this Agreement, it shall be the sole responsibility of the Allottee to intimate the same in writing to the LLP immediately and comply with necessary formalities if any, under the applicable laws. The LLP shall not be responsible towards any third party making payment/remittances on behalf of Allottee and such third party shall not have any right in the application/allotment of the said Apartment/ Plot apply for herein in any way and the LLP shall be issuing the payment receipts in favor of the Allottee only.

### 4. ADJUSTEMENT/ APPROPRIATION OF PAYMENTS:

The Allottee authorized the LLP to adjust/appropriate all payments made by him/her under any head of dues against lawful outstanding of the Allottee against the Apartment/Plot, if any, in his/her name and the Allottee undertakes not to object/demand/direct the LLP to adjust his payments in any manner.

#### 5. TIME IS ESSENCE:

The LLP shall abide by the time schedule for completing the Project as disclosed at the time of registration of the Project with the Authority and towards handing over the Plot to the Allottee and the common areas to the Maintenance Society or the competent authority, as the case may be.

#### 6. POSSESSION OF THE APARTMENT / PLOT:

- 6.1 Schedule for possession of the said Apartment of Plot The LLP agrees and understands that timely delivery of possession of the Plot to the Allottee and the common areas to the Maintenance Society or the competent authority, as the case may be, is the essence of the Agreement. The LLP assures to handover possession of the Plot of the Project in place on or after ...... unless there is delay or failure due to war, flood, drought, fire, cyclone earthquake or any other calamity caused by nature effecting the regular development of the real estate project ("Force Majeure"). If, however, the completion of Project is delayed due to the Force Majeure conditions then the Allottee agrees that the LLP shall be entitled to the extension of time for delivery of possession of the Plot, provided that such Force Majeure conditions are not of a nature which make it impossible for the contract to be implemented. The Allottee(s) agrees and confirms that, in the event it becomes impossible for the LLP to implement the project due to Force Majeure conditions, then this allotment shall stand terminated and the LLP shall refund to the Allottee(s) the entire amount received by the LLP from the Allottee with interest within forty-five days from that date. The LLP shall intimate the Allottee about such termination at least thirty days prior to such termination. After refund of the money paid by the Allottee, the Allottee agreed that he/ she shall not have any rights, claims etc. against the LLP and the LLP shall be released and discharged from all its obligations and liabilities under this Agreement.
- 6.2 Procedure for taking possession- The Promoter, upon obtaining the occupancy certificate if applicable from the competent authority if not then from chartered engineer shall offer in writing the possession of the Plot, to the Allottee(s) in terms of this Agreement to be taken within 2 (two) months from the date of issue of occupancy certificate. Provided that, in the absence of local law, the conveyance deed in favor of the Allottee shall be carried out by the Promoter within three months from the date of issue of occupancy certificate. The Promoter agrees and undertakes to indemnify the Allottee(s) in case of failure of fulfillment of any of the provisions, formalities, documentation on part of the Promoter. The Allottee(s), after taking possession, agree(s) to pay the maintenance charges as determined by the Promoter Maintenance Society, as the case may be, after the issuance of completion certificate for the Project. The Promoter shall handover the occupancy certificate of the Plot, as the case may be, to the Allottee at the time of conveyance of the same.
- 6.3 Failure of Allottee to take possession of Plot- Upon receiving a written intimation from the LLP as per Term No. 6.2 above, the Allottee(s) shall take possession of the Plot from the LLP by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement and the LLP shall give possession of the Plot to the Allottee(s).
- 6.4 Possession of the Allottee- After obtaining the occupancy certificate and handing over physical possession of the Plot to the Allottee, it shall be the responsibility of the LLP to handover the necessary documents and plan, including common areas to the Maintenance Society or the competent authority, as the case may be, as per the local laws:

Provided that, in the absence of any local law, the LLP shall handover the necessary documents and plans, including common areas, to the Maintenance Society or the competent authority, as the case may be, within thirty days after obtaining the completion certificate.

6.5 Cancellation by Allottee- The Allottee(s) shall have the right to cancel/withdraw his allotment in the Project as provided in the Act:

Provided that where the Allottee(s) proposes to cancel/withdraw from the Project without any fault of the LLP, the LLP herein is entitled to forfeit the booking amount paid for the allotment. The balance amount of money paid by the Allottee(s) shall be returned by the LLP to the Allottee(s) within forty-five days of such cancellation.

6.6 Compensation - The LLP shall compensate the Allottee in case of any loss, caused to him due to defective title of the land, on which the Project is being developed or has been developed, in the manner as provided under the Act and the claim for the interest and compensation under this provision shall not be barred by limitation provided under any law for the time being in force. Except for occurrence of a Force Majeure event, if the LLP fails to complete or is unable to give possession of the said Apartment/ Plot (i) in accordance with the terms of this Agreement, duly completed by the day specified in Term No. 6.1 above; or (ii) due to discontinuance of his business as a developer on account of suspension or revocation or expiry of the registration under the provisions of the Act; or for any other reason; the LLP shall be liable, on demand to the Allottee, in case the Allottee wishes to withdraw from the Project, without prejudice to any other remedy available, to return the total amount received by him in respect of the Apartment/ Plot, with interest including compensation in the manner as provided under the Act within forty-five days of it becoming due:

Provided that where if the Alloottee does not intent to withdraw from the Project the LLP shall pay the Allottee interest for every month of dealy, till the handing over of the possession of the Apartment/ Plot, which shall be paid by the LLP to the Allottee within forty-five days of it becoming due.

- REPRESENTATIONS AND WARRANTIES OF THE LLP: The LLP hereby represents and warrants to the Allottee(s) as follows:
  - (i) The LLP has absolute, clear and marketable title with respect to the said Land and the requisite rights to carry out development upon the said Land and absolute, actual, physical and legal possession of the said Land for the Project;
  - (ii) The LLP has lawful rights and requisite approvals from the competent authorities to carry out development of the Project;
  - (iii) There are no encumbrances upon the said Land or the Project;
  - (iv) There are no litigations pending before any Court of law or Authority with respect to the said Land, Project or the Unit;
  - (v) All approvals, licenses and permits issued by the competent authorities with respect to the Project, said Land and Unit are valid and subsisting and have been obtained by following due process of law. Further, the LLP has been and shall, at all times, remain to be in compliance with all applicable laws in relation to the Project, Unit and common areas;
  - (vi) The LLP has the right to enter into this Agreement and has not committed or omitted to perform any act or thing, whereby the right, title and interest of the Allottee(s) created herein, may prejudicially be affected;
  - (vii) The LLP has not entered into any agreement for sale and/or development agreement or any other agreement / arrangement with any person or party with respect to the said Land, including the Project and the said Unit which will, in any manner, affect the rights of Allottee(s) under this Agreement;
  - (viii) The LLP confirms that the LLP is not restricted in any manner whatsoever from selling the said Unit to the Allottee(s) in the manner contemplated in this Agreement;
  - (ix) At the time of execution of the conveyance deed the LLP shall handover lawful, vacant, peaceful, physical possession of the Unit to the Allottee(s) and the common areas to the Maintenance Society;
  - (x) The Schedule Property is not the subject matters of any HUF and that no part thereof is owned by any minor and /or no minor has any right, title and claim over the Schedule Property;
  - (xi) The LLP has duly paid and shall continue to pay and discharge all governmental dues, rates, charges and taxes and other monies, levies, impositions, premiums, damages and/or penalties and other outgoings, whatsoever, payable with respect to the said Project to the competent authorities till the completion certificate has been issued and possession of the Apartment/ Plot along with common areas (equipped with all the specifications, amenities and facilities) has been handed over to the Allottee and the Maintenance Society or the competent authority, as the case may be;
  - (xii) No notice from the Government or any other local body or authority or any legislative enactment, government order, notification (including any notice for acquisition or requisition of the said property) has been received by or served upon the LLP in respect of the said Land and/or the Project.

# 8. EVENTS OF DEFAULTS AND CONSEQUENCES:

- 8.1 Subject to the Force Majeure clause, the LLP shall be considered under a condition of default, in the following events, namely:-
  - (i) The LLP fails to provide possession of the plot to the Allottee(s) within the time period specified in Term No. 6.1 above in this Agreement or fails to complete the Project within the stipulated time disclosed at the time of registration of the Project with the Authority. For the purpose of this clause, "Possession" shall mean that the plot shall be in a habitable condition which is complete in all respects including the provision of all specifications, amenities and facilities, as agreed to between the parties, and for which completion certificate, as the case may be, has been issued by the competent authority;
  - (ii) Discontinuance of the LLP's business as a developer on account of suspension or revocation or expiry of his registration under the provisions of the Act or the rules or regulations made there under.
- 8.2 In case of default by the LLP under the conditions listed above, Allottee(s) is entitled to the following:-
  - Stop making further payments to the LLP as demanded by the LLP. If the Allottee(s) stops making
    payments, the LLP shall correct the situation by completing the development milestones and only
    thereafter the Allottee(s) be required to make the next payment without any interest; or
  - (ii) The Allottee(s) shall have the option of terminating the Agreement in which case the LLP shall be liable to refund the entire money paid by the Allottee(s) under any head whatsoever towards the purchase of the Apartment, along with interest within forty-five days of receiving the termination notice:

Provided that where an Allottee(s) does not intend to withdraw from the Project or terminate the Agreement, he shall be paid, by the LLP, interest for the period of delay till the handing over of the possession of the Apartment/ Plot, which shall be paid by the LLP to the Allottee within forty-five days of it becoming due.

- 8.3 The Allottee(s) shall be considered under a condition of default, on the occurrence of the following events:
  - (i) In case the Allottee(s) fails to make payments for consecutive demands made by the LLP as per the payment plan stated above, despite having been issued notice in that regard, the Allottee(s) will be liable to pay interest to the LLP on the unpaid amount.
  - (ii) In case of default by Allottee under the conditions listed above continues for a period beyond one month consecutive months in this regard, the LLP may cancel the allotment of the Plot in favour of the Allottee(s) and refund the money paid to him by the Allottee(s) by deducting the booking amount and the interest liabilities and this Agreement shall thereupon stand terminated without any intimation to Allottee.

Provided that the LLP shall intimate the Allottee about such termination at least thirty days prior to such termination.

#### 9. CONVEYANCE OF THE SAID PLOT:

The LLP, on receipt of Total Price of the Plot as per Term No.1.2 under the Agreement from the Allottee shall execute a allotment letter of LLP and the LLP shall be responsible for issue of JDA allotment letter in the name of allottee from competent authority "JAIPUR DEVELOPMENT AUTHORITY".

Provided that, in absence of local law, the conveyance deed in favour of the Allottee shall be carried out by the LLP.

# 10. MAINTENANCE OF THE SAID PROJECT:

The LLP shall be responsible for providing and maintaining the essential services in the Project, till the taking over of the maintenance of the Project by the Maintenance Society upon the issuance of the completion certificate of the Project. The cost of such maintenance has been included in the Total Price of the Plot.

#### 11. DEFECT LIABILITY:

It is agreed that in case any defect or any other defect in workmanship, quality or provision of services or any other obligations of the Promoter as per this Agreement relating to such development is brought to the notice of the Promoter within a period of five years by the allottee from the date of handing over possession, it shall be the duty of the Promoter to rectify such defects without further charge, within thirty days, and in the event of Promoter's failure to rectify such defects within such time, the aggrieved Allottee(s) shall be entitled to receive appropriate compensation in the manner as provided under the Act.

#### 12. GENRAL COMPLIANCE WITH RESPECT TO THE PLOT:

- (i) Subject to Term 11 above, the Allottee(s) shall, after taking possession, be solely responsible to maintain the said Plot at his/her own cost, in good repair and condition and shall not do or suffer to be done anything in or to the said Plot, which may be in violation of any laws or rules of any authority.
- (ii) The Allottee further undertakes, assures and grantees that he/ she would not put any sign-board/nameplate, neon light, publicity material or advertisement material etc. anywhere on the exterior of the Project, or common areas. Further the Allottee shall not store any hazardous or combustible goods in the Plot.
- (iii) The Allottee shall plan and distribute its electric load in conformity with the electric systems installed by the concerned authority. The Allottee shall be responsive -for any loss or damages arising out of breach of any of the aforesaid conditions.

#### 13. COMPLIANCE OF LAWS, NOTIFICATIONS ETC. BY PARTIES:

The Parties are entering into this Agreement for the allotment of a Plot with the full knowledge of all laws, rules, regulations, notifications applicable to the Project.

#### 14. ADDITIONAL DEVELOPMENT:

The LLP undertakes that it has no right to make additions or to put up additional structure anywhere in the Project after the building plan, layout plans sanction plan and specifications, amenities and facilities has been approved by the competent authorities and disclosed, except for as provided in the Act.

#### 15. LLP SHALL NOT MORTGAGE OR CREATE A CHARGE:

After the LLP executes this Agreement he shall not mortgage or create a charge on the said Plot and if any such mortgage or charge is made or created then notwithstanding anything contained in any other law for the time being in force, such mortgage for charge shall not affect the right and interest of the Allottee(s) who has taken or agreed to take such Apartment/ Plot/ Building.

#### 16. BINDING EFFECT:

Forwarding this Agreement to the Allottee(s) by the LLP does not create a binding obligation on the part of the LLP or the Allottee(s) until, firstly, the Allottee(s) signs and delivers this Agreement with all the Schedules along with the payments due as stipulated in this Agreement within thirty days from the date of receipt by the Allottee(s) and when intimated by the LLP. If the Allottee(s) fails to execute and deliver to the LLP this Agreement within 30 (thirty) days from the date of its receipt by the Allottee(s) then the LLP shall serve a notice to the Allottee(s) for rectifying the default, which if not rectified within 30 (thirty) days from the date of its receipt by the Allottee(s), application of the Allottee shall be treated as cancelled without any intimation to the Allottee and all sums deposited by the Allottee(s) in connection therewith including the booking amount shall be returned to the Allottee(s) without any interest or compensation whatsoever.

#### 17. ENTIRE AGREEMENT:

This Agreement, along with its schedules, constitutes the entire Agreement between the Parties with respect to the subject matter hereof, and supersedes any and all understandings, any other agreements, allotment letter, correspondences, arrangements whether written or oral, if any, between the Parties in regard to the said Plot.

18. RIGHT TO AMEND: This Agreement may only be amended through written consent of the Parties.

#### 19. PROVISIONS OF THIS AGREEMENT APPLICABLE ALLOTTEE/ SUBSEQUENT ALLOTTEES:

It is clearly understood and so agreed by and between the Parties hereto that all the provisions contained herein and the obligations arising hereunder in respect of the said Plot and the Project shall equally be applicable to and enforceable against and by any subsequent Allottee of the Plot, in case of a transfer, as the said obligations go along with the Plot for all intents and purposes.

#### 20. WAIVER NOT A LIMITATION TO ENFORCE:

- 20.1 The LLP may, at least solve option and discretion, without prejudice to its rights as said out in this Agreement wave the breach by the Allottee in not making payments as per the payment plan mentioned this Agreement including waving the payment of interest for delayed payment. It is made clear and so agreed by the Allottee that exercise of discretion by the LLP in the case of one allottee shall not be construed to be a precedent and /or binding on the LLP to exercise such discretion in the case of other allottees.
- 20.2 Failure on part of the Parties to enforce at any time or for any period of time the provisions hereof shall not be construed to be a waiver of any provisions or of the right thereafter to enforce each and every provision.

#### 21. SEVERABILITY:

If any provision of this Agreement shall be determined to be void or unenforceable under the Act or the Rules and Regulations made there under or under other applicable laws, such provisions of the Agreement shall be deemed amended or deleted in so far as reasonably inconsistent with the purpose of this Agreement and to the extent necessary to the conform to the Act or the Rules and Regulations made there under or the applicable law, as the case may be, and remaining provisions of this Agreement shall remain valid and enforceable as applicable at the time of execution of this Agreement.

# 22. METHOD OF CALCULATION OF PROPORTIONATE SHARE WHEREVER REFERRED TO IN THE AGREEMENT:

Wherever in this Agreement it is stipulated that the Allottee(s) has to make any payment, in common with other allottees in the Project, the same shall be the proportion which the area of the Plot bears to the total area of all the Plots in the Project.

#### 23. FURTHER ASSURANCES:

Both Parties agree that they shall execute, acknowledge and deliver to the other such instruments and take such other actions, in additions to the instruments and actions specifically provided for herein, as may be reasonably required in order to effectuate the provisions of this Agreement or of any transaction contemplated herein or to confirm or perfect any right to be created or transferred hereunder or pursuant to any such transaction.

#### 24. PLACE OF EXECUTION:

The execution of this Agreement shall be completed only upon its execution by the LLP through its authorized signatory at the LLP's Office, or at some other place, which may be mutually agreed between the LLP and the Allottee, in **Jaipur** after the Agreement is duly executed by the Allottee and the LLP.

#### 28. GOVERNING LAW:

That the rights and obligations of the parties under or arising out of this Agreement shall be construed and enforced in accordance with the Act, rules and regulations made there under including other applicable laws of India for the time being in force.

# 29. DISPUTE RESOLUTION:

All or any dispute arising out of or touching upon or in relation to the terms and conditions of this Agreement including the interpretation and validity thereof and the respective rights and obligations of the Parties, shall be settled amicably by mutual discussions, between the Parties, failing which the dispute shall be settled in the manner as provided under the Act.
