

3. The Estimated Cost Incurred till date is calculated at Rs. 12,18,70,000.00/- (Rs. Twelve Crore Eighteen Lakh Seventy Thousand Only) (Total of Table A and B). The amount of Estimated Cost incurred is calculated on the base of amount of Total Estimated Cost.


