The estimated Total Cost of project is with reference to the Civil and allied works required to be completed for the purpose of obtaining occupation certificate/ completion certificate for the building(s).
3. The Estimated Cost Incurred till 30th September, 2024 is calculated at **Rs. 99,15,631/- (Rs. Ninety-Nine Lakh Fifteen Thousand Six Hundred Thirty-One Only)** (Total of Table A and B). The amount of Estimated Cost incurred is calculated on the base of amount of Total Estimated Cost.
