






# **DECLARATION** Affidavit cum Declaration



- 1. That Promoter Firm has a legal title to the land on which the development of the project is proposed.
- 2. That the Promoter has taken a Loan from Shubham Housing Development Finance Company Ltd.
- 3. That the time period within which the project or phase thereof, as the case may be, shall be completed by promoter is 31-12-2026
  - 4. That seventy per cent of the amounts realized by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

  - 8. That promoter shall take all the pending approvals on time, from the competent authorities.
  - 9. That promoter has furnished such other documents as have been specified by the rules and regulations made under the Real Estate (Regulation and Development) Act, 2016.

10. That promoter shall not discriminate on the basis of caste, religion, region, language, sex or marital status against any allottee at the time of allotment of any apartment, plot or build as a small be on any grounds.
