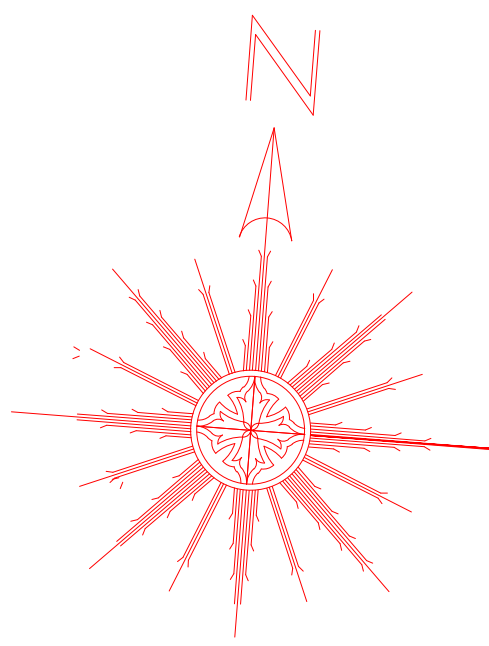
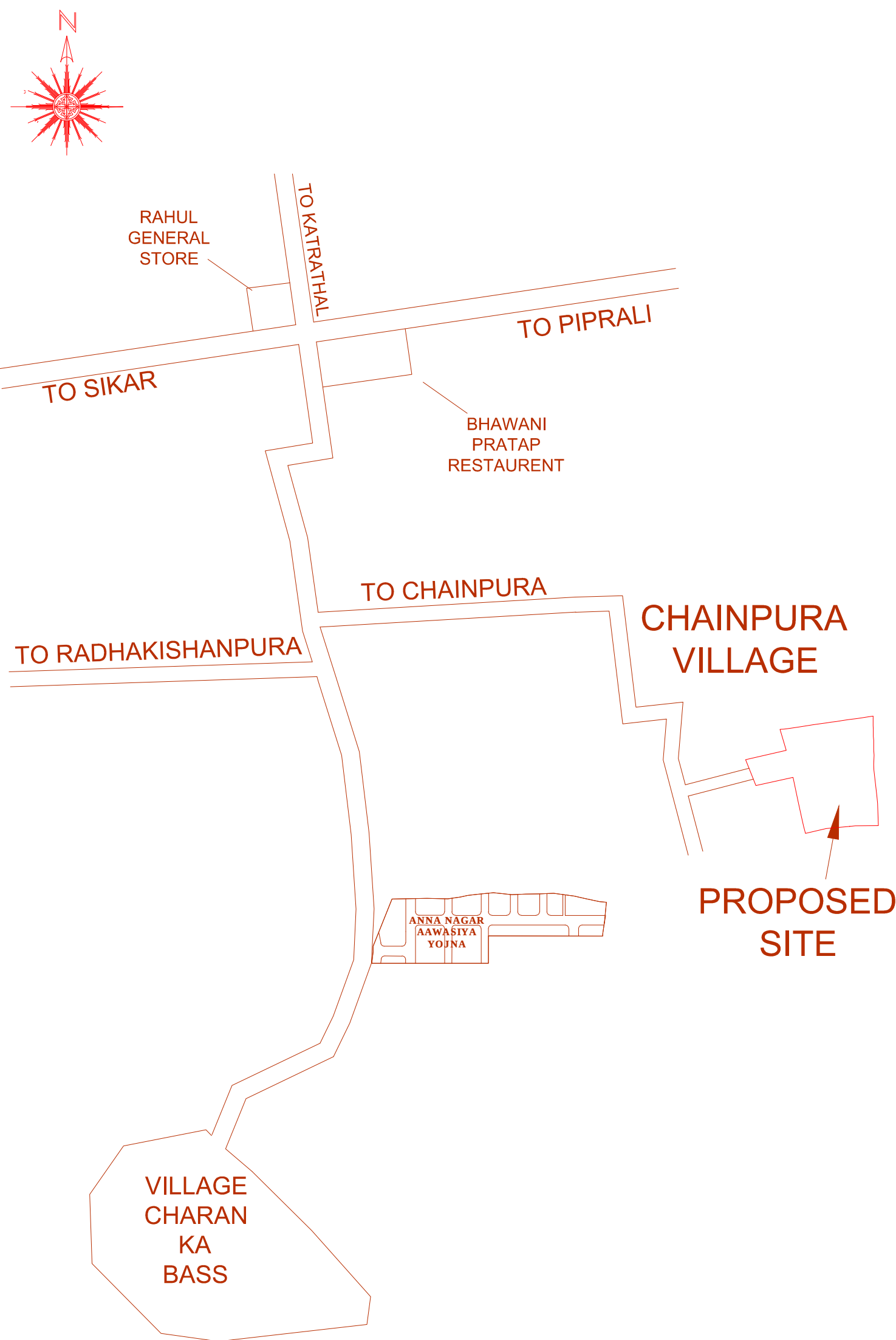

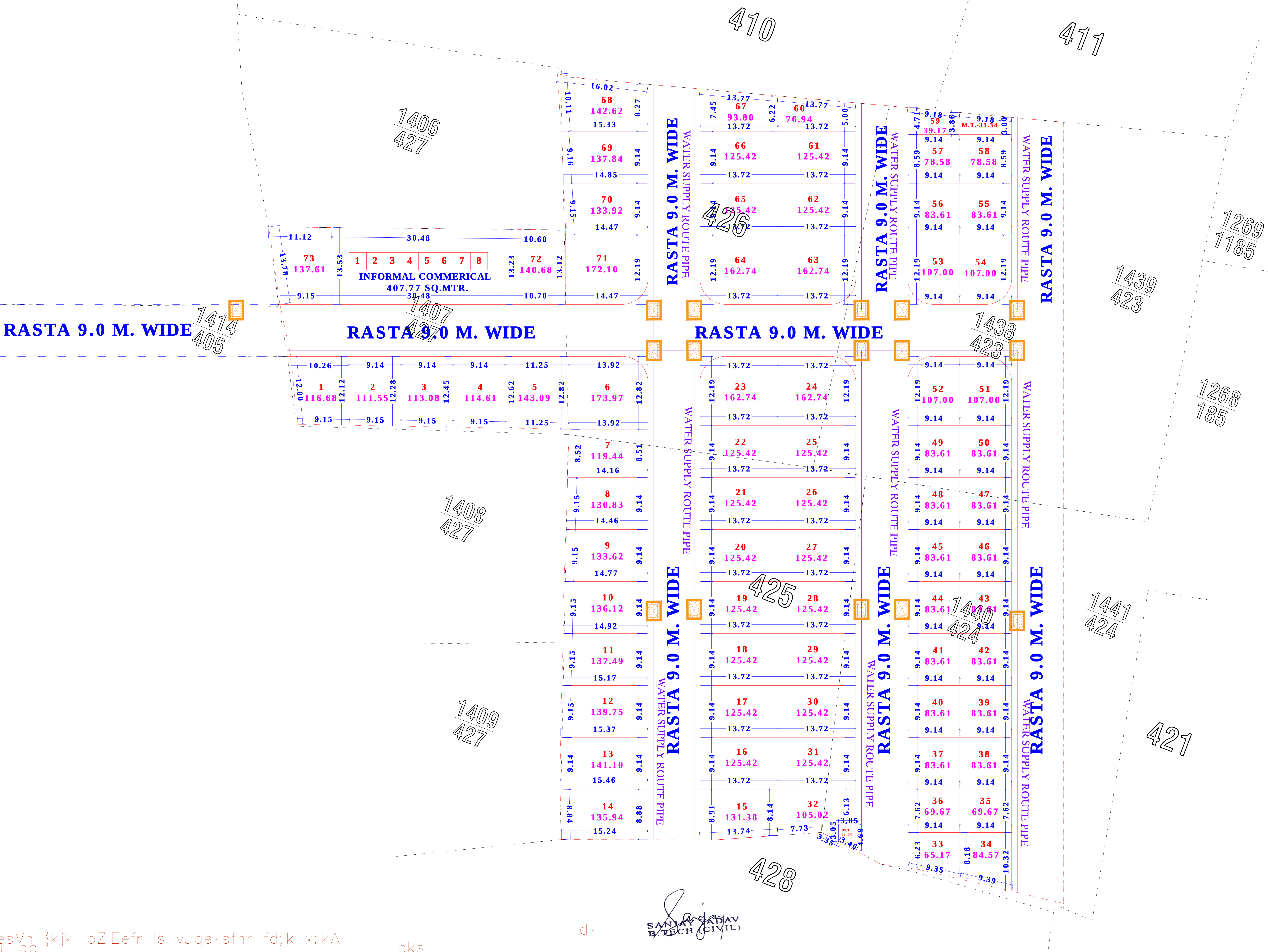

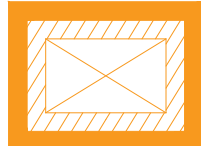
PROPOSED ROAD 18.0 METER WIDE



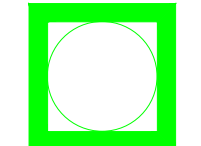

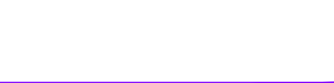
