

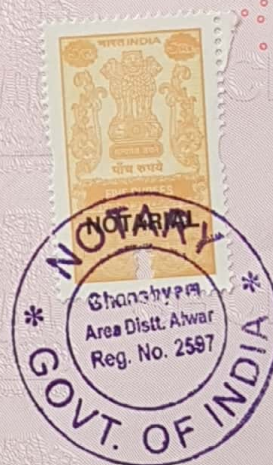

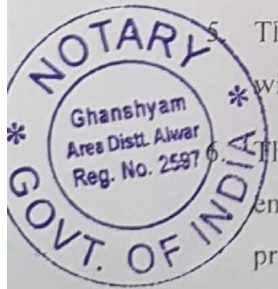

AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr. Pankaj Joshi duly authorized by the Promoter of the proposed Project vide the authorization dated 24.05.2021

I, Pankaj Joshi Shri B.M. Sharma, aged 40 years, having office at 4th Floor, Village Centre, Vasundhara Nagar, Bhiwadi, Dist.-Alwar, Rajasthan duly authorised by the promoter of the proposed project, do hereby solemnly declare, undertake and state as under:

1. That the Promoter has legal title of the Land on which the development of the project is proposed.
2. That the Said Land is free from encumbrances.
3. That the time period within which the project or phase thereof, as the case may be, shall be completed by promoter is **31.12.2024**.
4. That seventy per cent of the amounts realised by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.



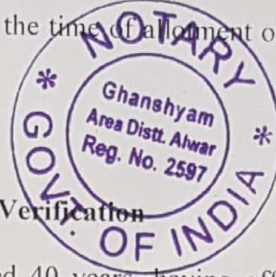
