Sub: - NOC for ground water withdrawal to M/s Ashiana Housing Ltd., in respect of the proposed Group Housing project "Ashiana Nirmay" located at Khasra No. 179, 173, 174, 172, 171, 169 (P), Village Thada, Block Tijara, District Alwar, Rajasthan- reg.

Refer to your application dated 3.4.2014 on the above cited subject. Based on the recommendations of the Regional Director, Central Ground Water Board, Western Region, Jaipur vide their office letter no. TS/21B(662)/CGWA/WR/2014- 216 dated 20.10.2015 and further deliberations on the subject, the NOC of Central Ground Water Authority is hereby accorded to M/s Ashiana Housing Ltd., in respect of the proposed Group Housing project "Ashiana Nirmay" located at Khasra No. 179, 173, 174, 172, 171, 169 (P), Village Thada, Block Tijara, District Alwar, Rajasthan. The NOC is, however subject to the following conditions:-

1. The firm may abstract 180 m³/day (not exceeding 65,700 m³/year) of ground water, through proposed two (2) tubewells only. No additional ground water abstraction structures to be constructed for this purpose without prior approval of the CGWA.
2. The wells to be fitted with water meter by the firm at its own cost and monitoring of ground water abstraction to be undertaken accordingly on regular basis, at least once in a month. The ground water quality to be monitored twice in a year during pre monsoon and post monsoon periods.
3. M/s Ashiana Housing Ltd., shall, in consultation with the Regional Director, Central Ground Water Board, Western Region, Jaipur implement ground water recharge measures to the tune of 16,335 m³/year, for augmenting the ground water resources of the area.
4. The photographs of the recharge structures after completion of the same are to be furnished immediately to the Regional Director, Central Ground Water Board, Western Region, Jaipur for verification and under intimation to this office.



5. The firm at its own cost shall install piezometers fitted with automatic water level recorders at suitable locations and execute ground water regime monitoring programme in and around the project area on regular basis in consultation with the Central Ground Water Board, Western Region, Jaipur.
6. The ground water monitoring data in respect of S. No. 2 & 5 to be submitted to Central Ground Water Board, Western Region, Jaipur on regular basis at least once in a year.
7. The firm shall ensure proper recycling and reuse of waste water after adequate treatment.
8. Action taken report in respect of S. No. 1 to 7 may be submitted to CGWA within one year period.
9. The permission is liable to be cancelled in case of non-compliance of any of the conditions as mentioned in S. No. 1 to 8.
10. This NOC is subject to prevailing Central/State Government rules/laws or Court orders related to construction of tubewell/ground water withdrawal/construction of recharge or conservation structures/discharge of effluents or any such matter as applicable.
11. This NOC does not absolve the applicant / proponent of his obligation / requirement to obtain other statutory and administrative clearances from other statutory and administrative authorities.
12. The NOC does not imply that other statutory / administrative clearances shall be granted to the project by the concerned authorities. Such authorities would consider the project on merits and be taking decisions independently of the NOC.
13. This NOC is valid for two years from the date of issue of this letter.




