Sub: - NOC for ground water withdrawal to M/s Ashiana Housing Limited in respect of their proposed Residential apartment project "Ashiana Tarang" located at Village Milakpuri, Block Tijara, District Alwar, Rajasthan – reg.

Refer to your application for grant of NOC for ground water withdrawal dated 10/12/2016. Based on recommendations of Regional Director, Central Ground Water Board, Western Region, Jaipur vide his letter dated 14/03/2018 with clarification dated 03/08/2017 and further deliberations on the subject, the NOC of Central Ground Water Authority for ground water withdrawal is hereby accorded to M/s Ashiana Housing Limited in respect of their Residential apartment project "Ashiana Tarang" located at Village Milakpuri, Block Tijara, District Alwar, Rajasthan. The NOC is valid from 10/05/2018 to 09/05/2020 and is subject to the following conditions:-

1. The firm may abstract **496 cu.m/day** of ground water (and not exceeding **1,81,040 cu.m/year**) through six (6) proposed tube wells only. No additional ground water abstraction structures shall be constructed for this purpose without prior approval of the CGWA.

2. All the wells shall be fitted with digital water meter by the firm at its own cost and monthly ground water abstraction data shall be recorded in a log book. Compliance to this condition shall be reported within one month from the date of issue of this letter.

3. **M/s Ashiana Housing Limited, Ashiana Tarang,** in consultation with the Regional Director, Central Ground Water Board, Western Region, Jaipur shall implement ground water recharge measures atleast to the tune of **26,320 cu.m/year** as proposed for augmenting the ground water resources of the area within six months from the date of issue of this letter. Firm shall also undertake periodic maintenance of recharge structures at its own cost.

4. The photographs of the recharge structures after completion of construction of the same shall be furnished immediately to the Regional Director, Central Ground Water Board, Western Region, Jaipur for verification under intimation to this office.

5. The firm at its own cost shall construct one (1) observation well (piezometer) at suitable location and install digital water level recorder for monthly ground water level

monitoring in consultation with the Regional Director, Central Ground Water Board, Western Region, Jaipur.

6. The ground water quality shall be monitored once in a year (during pre monsoon period).

7. The monitoring data in respect of S. No. 2, 5 & 6 shall be submitted to the Regional Director, Central Ground Water Board, Western Region, Jaipur on regular basis at least once in a year.

8. The firm shall ensure proper recycling and reuse of waste water after adequate treatment.

9. Action taken report in respect of S. No. 1 to 8 shall be submitted to CGWA within one year period.

10. This NOC is liable to be cancelled in case of non-compliance of any of the conditions as mentioned in S. No. 1 to 9.

11. This NOC is subject to prevailing Central/State Government rules/laws or Court orders related to construction of tubewell/ground water withdrawal/construction of recharge or conservation structure/discharge of effluents or any such matter as applicable.

12. The firm shall report self compliance online in the website (www.cgwanoc.gov.in) within one year from the date of issue of this NOC.

13. This NOC does not absolve the applicant / proponent of this obligation / requirement to obtain other statutory and administrative clearances from other statutory and administrative authorities.

14. The NOC does not imply that other statutory / administrative clearances shall be granted to the project by the concerned authorities. Such authorities would consider the project on merits and be taking decisions independently of the NOC.
