

Affidavit Cum Declaration of Mr. Rohit Meena promoter of the Proposed Project.

- I, Rohit Meena S/o Kalyan Sahay R/o Plot NO. 29, Roop Nagar-2nd, Near Mahesh Nagar, Lalkothi, Jaipur-302015 Do Hereby Solemnly Declare, Undertake and State As Under: -
- That we promoter have the legal title of the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- That the time period within which the project or phase thereof, as the case may be, shall be completed by promoter is 31.07.2026
- 4. That seventy per cent of the amounts realized by promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

- 6. That the amounts from the separate account shall be withdrawn only after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

That I / promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That I /promoter shall take all the pending approvals on time, from the competent authorities.
- 9. That I /promoter have / has furnished such other documents as have been specified by the ELIC rules and regulations made under the Real Estate (Regulation and Development) Act; 2016 (INDIA)


