

- 1. That Deepak Parihar and Govind Singh Parihar are the joint owners of the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project or phase thereof, as the case may be, shall be completed by promoters on or before 31-03-2026.

That we / promoters shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That we/promoters shall take all the pending approvals on time, from the competent authorities.

That we /promoters have / has furnished such other documents as have been SHEISHIS Decision by the rules and regulations made under the Real Estate (Regulation and JODHOUR (RADevelopment) Act, 2016.

EXPIRY DATE. That we /promoters shall not discriminate on the basis of caste, religion, region, language, sex or marital status against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
