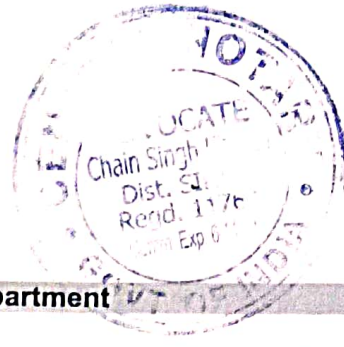
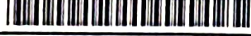

DECLARATION




