



Affidavit cum Declaration of Mr. Bhagwan Kumar duly authorized by the Promoter of the proposed Project vide the authorization dated 01.06.17

- I, Bhagwan Kumar S/o Late Shankar Poddar, aged 46 years, r/o 19/122, Shivam Khand, Vasundhara, Ghaziabad duly authorised by the promoter of the proposed project, do hereby solemnly declare, undertake and state as under:
- 1. That the Promoter has a legal title of the Land on which the development of the project is proposed
- 2. That the time period within which the project or phase thereof, as the case may be, shall be completed by Promoter is June, 2018 including six months grace period.
- 3. That seventy per cent of the amounts realised by Promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 4. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 5. That the amounts from the separate account shall be withdrawn only after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
- 6. That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

7. That the Promoter shall take all the pending approvals on time, from the competent authorities.

8. That the Promoter have I has furnished such other documents as have been specified by the rules and regulations made under the Real Estate (Regulation and Development) Act, 2016.

9. That the Promoter shall not discriminate on the basis of caste, religion, region, language, sex or marital status against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
