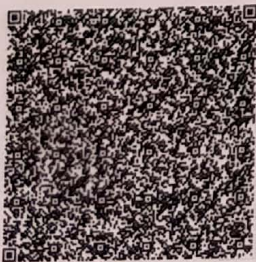

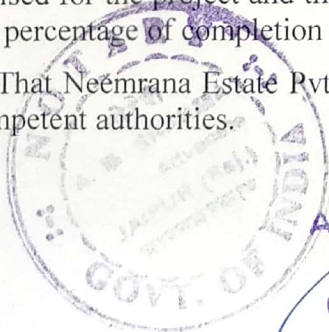

DECLARATION


