DECLARATION

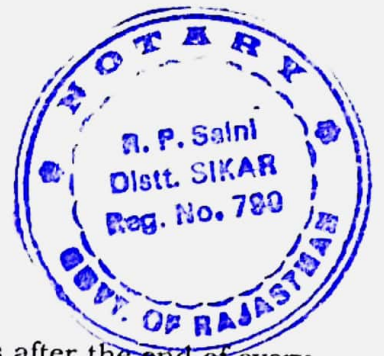
