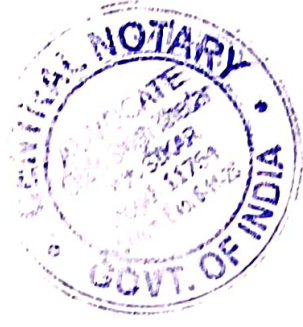

DECLARATION
