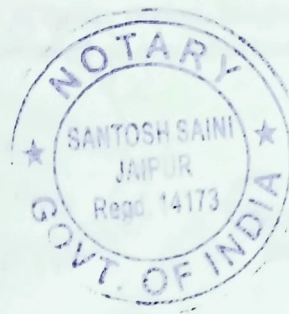

DECLARATION

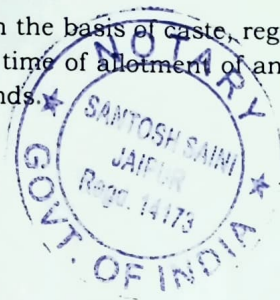
