Apropos above, it is to inform you that applications for Consent to Establish under reference is hereby refused under the provisions of section 21(4) of Air (Prevention & Control of Pollution) Act, 1981 and section 25/26 of Water (Prevention & Control of Pollution) Act, 1974 for the reasons that:

- 1 That the industry has not submitted copy of Environmental Clearance letter for the project
- 2 That the industry submitted vide letter dated 22/02/2016 that UIT Kota has changed project planning and approved the drawings of the project. The unit also mentioned that they have applied the revised application for obtaining Environmental Clearance as per the drawings and project detail approved by UIT Kota. That the unit has not submitted revised Consent to Establish application.

It may be noted that the industry's fresh application for grant of Consent to Establish, submitted soon after the refusal, shall not be treated as complete application unless it is supported with evidence-based proof for addressal of the issues/ reasons for the refusal of earlier consent or application, and thus may again be refused without any further notice.

It is further to inform you that after refusal of Consent to Establish legally you can not Establish the plant.
