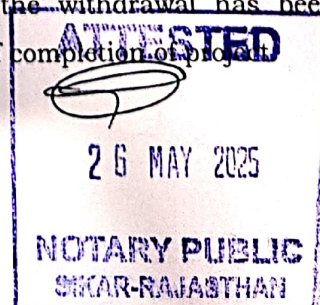

DECLARATION
