 - iv. The registration shall valid upto **30-04-2026**(Estimated Finish Date) unless extended by the Real Estate Regulatory Authority in accordance with Section 6 of the Real Estate(Regulation and Development) Act, 2016 read with rule 7 of the Rajasthan Real Estate(Regulation and Development) Rules, 2017;

 - vi. The promoter shall not contravene the provisions of any other law for the time being in force in the area where the project is being developed.
