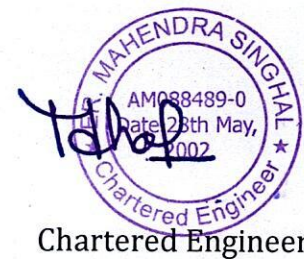
***Note:**
