We estimate total estimated cost of completion of the building(s) of the aforesaid project under reference as Rs 6,03,88,340.00 + 85,00,000.00 = 6,88,88,340.00- (Rupees SIX CRORE EIGHTY EIGHT LAC EIGHTY EIGHT THOUSAND THREE HUNDRED AND FORTY RUPEES ONLY) (Total of table A and B). The estimated total cost of project is with reference to the civil and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building(s).
2. The estimated cost of Land & Development Cost incurred till date is calculated as Rs. 1,79,00,522/- (Rupees One Crore Seventy nine Lac Five Hundred and Twenty Two Rupees Only) (total of table A and B). The amount of estimated cost incurred is calculated on the base of amount of total estimated cost.
3. The balance cost of completion of the civil and allied works of the subject project to obtain occupation certificate / completion certificate from Jaipur Development Authority, Jaipur (planning authority) is estimated at Rs. 5,09,87,818/- Rupees Five Crore Nine lack Eighty Seven Thousand Eight Hundred and Eighteen Rupees only) (Total of table A and B).

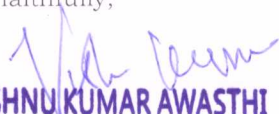
