The estimated total cost of the project is with reference to the Civil & Allied works required to be completed for obtaining occupation certificate / completion certificate for the building(s).
2. The estimated cost incurred till 30/06/2025 is calculated at **Rs. 3,27,00,251/- (As per table of A and B)**. The amount of estimated cost incurred is calculated on the base amount of total estimated cost.
