2- As per section 4(2)(1)(D) of the Act the Promoter is required to transfer only 70% of the funds realised from the allottees of the real estate project into the RERA Designated Account. In the cases where the promoter has transferred more than 70% of the said funds then in that case it is only justified that withdrawal of such excess money deposited should not exaust the withdrawal limit thus such withdrawal is added back in the total withdrawal limit.
